He will also update the tree removal application to include the requirement of a NJ licensed tree expert and a section to indicate if the tree is on private property or Borough owned property. The Deputy Clerk will create a procedure list for the Governing Body to approve, and send the current tree removal application to Mr. Gillin-Schwartz.
