Engineering Report

Borough of West Cape May

- 1.) **FY 2010 USDA RD Sanitary Sewer Extension, Water Main Replacement and Meter Installation Program and FY 2012 NJDOT Municipal Aid/Bike Path**
 - Status:
 - USDA made the formal announcement of the grant/loan in the amount of \$708,000 Grant and \$2,305,000 Loan.
 - Work on Park Boulevard from Myrtle Street to Leaming Avenue is substantially complete. Contractor to complete punchlist.
 - A total of twenty-six (26) parallel parking spaces have been created along side the bike path.
 - Landis and Stewart pavement remediation is scheduled for early October.
 - 3rd Avenue is paved.
 - 5th Avenue is paved.
 - 4th Avenue is paved.
 - Park Boulevard from Leaming Avenue to Broadway and intersecting streets began September 3, 2013 and to be completed by December 31, 2013.
 - Contractor has begun laying sanitary on Central Avenue, from Broadway toward Park Boulevard.
 - Contractor has issued notices to residents of the revised schedule and will continue to provide updates.

- 2.) **LSRP Services Case No. 00-08-24-1117-35 (Borough Hall)**
 - Status:
 - Sampling is complete.
 - Test results show no remedial action necessary.
 - RV& W's LSRP prepared Unrestricted Response Action Outcome (RAO) for the four (4) areas of concern. The Mayor has signed the application and returned to RV & W for submission to NJDEP.
 - Awaiting NJDEP concurrence.

- 3.) **FY 2014 Municipal Aid Project Discussion**
 - State Street (Fourth Street to Sixth Street)
 - Phase 4 Bike Path Leaming Avenue (Park Boulevard to Cape May City Line)
 - RV&W to submit no later than September 20, 2013.
