1.) FY 2010 USDA RD Sanitary Sewer Extension, Water Main Replacement and Meter Installation Program

A.) Pump Stations

- Contracts have been signed with B & H Contracting in the amount of \$300,000.00. USDA has issued its concurrence to award.
- Shop drawings have been processed.
- Change Order for extension of time was approved to September 23, 2016.
- West Drive pump station and Fourth Avenue pump station to be completed by September 23, 2016.

B.) Portable Emergency Generator

- Contracts have been signed and forwarded to USDA for concurrence.

C.) Renovation of Water & Sewer Department Storage Building.

- RV&W prepared letter requesting determination of eligibility for the rehabilitation of the water & sewer building. USDA concurrence has been received.
- RV&W coordinating with Mr. Greg Basile in the purchase of materials and equipment. Labor shall be provided by the Borough for the majority of the work. Other items of work will be procured through written proposals.
- New roof, concrete floor, entrance ramp, and windows are complete.
- Construction is on schedule.
