Borough of West Cape May

1.) **FY 2010 USDA RD Sanitary Sewer Extension, Water Main Replacement and Meter Installation Program**

USDA has approved the Borough's request for the Replacement of the Myrtle Avenue Sanitary Intercept Sewer from Broadway to Park Boulevard and the Rehabilitation of the Broadway Sanitary Sewer Pump Station

- RV&W to prepare two (2) individual bid documents
 - A. Broadway Pump Station
 - B. Myrtle Street Sanitary Sewer

2.) **Broadway Sanitary Sewer Pump Station Schedule**

- RV&W to prepare close out documents. We anticipate close out by December 31, 2015.

3.) **Myrtle Avenue Sanitary Sewer Schedule**

- The tentative schedule for the Myrtle Avenue Sanitary Sewer:

Pre-Construction Meeting	Dec. 15, 2015
Construction Start	Jan. 4, 2016
Construction Complete	May 27, 2016

- RV&W assisting the Borough in the submission of USDA required forms to be provided to USDA prior to December 15, 2015.

4.) **FY 2014 Municipal Aid Project Discussion**

- The Borough has been awarded a NJDOT Municipal Aid Grant in the amount of \$172,000.00 for State Street (Fourth Street to Sixth Street).
- RV&W preparing close out documentation for NJDOT for final payment.

5.) FY 2015 Municipal Aid Project

- Reconstruction of Green Street (4th Avenue to 5th Avenue) approved for \$175,000.00. The Borough has authorized RV&W to proceed.
- Construction is Complete.
- Awaiting final payment request form the Contractor.

6.) FY 2016 Municipal Aid Project

- Municipal Aid Application for Leaming Avenue, Park Boulevard to Borough of West Cape May and City of Cape May municipal boundary has been submitted to NJDOT.
