NFIP Community Rating System: Nothing new to report at this time.

West Cape May Elementary Requests: The School Superintendent sent an email requesting the Borough consider hiring crossing guards and installing a crosswalk. Deputy Mayor Burke suggested they consider the safety patrol program provided by AAA. The Clerk will draft a letter advising Mr. Savio of the Board decision.
