Resolution #005-13 Matthew Notch, Block 55, Lot 23.01, 289 Sixth Avenue:

On motion of Doris Jacobsen, seconded by Art Joblin, the resolution was approved on roll call vote as follows: Kulkowitz and O’Neill abstaining, all remaining members present voting in the affirmative.

Application 008-12, Heather Wertley, Block 5, Lot 9.2, 145 York Avenue: The applicant was not present. Solicitor Russell received a call from the attorney for the applicant asking that the board to table the application to allow him time to apply to a judge to have the condition that the property be restricted to single family usage removed from the deed. Mark Kulkowitz made a motion, seconded by Diane Rea, to table the application until the following meeting to allow the applicant time to submit a letter clarifying their request. The motion was carried unanimously on roll call vote. At the June 11th meeting, the board can decide whether to table or dismiss the application without prejudice.
