1.) FY 2010 USDA RD Sanitary Sewer Extension, Water Main Replacement and Meter Installation Program

A.) Pump Stations

- West Drive pump station and Fourth Avenue pump station are completed.
- RV&W is finalizing USDA closeout documents.

B.) Portable Emergency Generator

- Contractor is completing the standardization of the connections of both generators and the pump stations.

C.) Renovation of Water & Sewer Department Storage Building.

E.) Myrtle Avenue Sanitary Sewer
