Greeting Vendors,

The West Cape May Farmers Market will be entering its 22nd season this year and the planning is underway! The market will run a full ten (10) weeks beginning June 20th and going through August 29th, each Tuesday between 3:00pm and 7:30pm, **with the exception of July 4, 2023 when no market will take place.**

Attached is the 2023 Vendor Application and 2023 Rules and Regulations. Please review the Rules and Regulations for more information regarding fees, payment, insurance and market logistics. We are pleased to announce that booth fees will once again remain the same for the 2023 season. Also, the market will once again allow for a limited sharing of booths.

Our objective is to offer a variety of products to meet the needs of our shoppers and keep the market interesting. Please return your completed application and fees as soon as possible. The West Cape May Farmers Market Committee of Volunteers (COV) will review all applications to the market. You must be approved by the COV before attending the market. Shared spaces must be pre-approved by the COV and will be limited to like vendors (for example: artist and artist). The COV has the discretion to deny any applications received. Any applicants who are denied will receive a full refund.

All food vendors must receive approval per NJAC 24:8 from the Cape May County Health Department prior to attending the market. This is inclusive of NJAC 24:8-11 regarding Cottage Food Operators. For further information, please contact the Cape May County Health Department at (609) 465-1187.

All vendors are encouraged to familiarize themselves with state law P.L. 2020 C. 117, banning plastic single use bags and polystyrene food containers, as well as providing plastic straws by request.
